RESOLUTION

WHEREAS, it is in the best interests of the County of Stanislaus and the employees of the County of Stanislaus to provide that Government Code Sections 31621.5 and 31639.5, shall become applicable in Stanislaus County; and

WHEREAS, the adoption of such sections will implement the agreement between Stanislaus County and the Stanislaus County Employees Association as specified in the 1975-1976 Memorandum of Understanding; and

WHEREAS, to further implement such agreement, this Board elects to pay one-half the costs of the contributions which are assessed for cost of living increase pursuant to Government Code Section 31870.2; *31870.1 and Ordinance No. 94 June 24, 1969 Ordinance Code 2.252.*

NOW, THEREFORE, BE IT RESOLVED that Sections 31621.5 and 31639.5 be, and the same hereby are, adopted and such sections shall become applicable in Stanislaus County effective December 1, 1975.

BE IT FURTHER RESOLVED that pursuant to Government Code Section 31873, this Board elects to pay one-half the costs of the contributions which would otherwise be assessed to the individual members, effective December 1, 1975.

Upon motion of Supervisor Paul, seconded by Supervisor Simon, the foregoing resolution was passed and adopted at a regular meeting of the Board of Supervisors of the County of Stanislaus, State of California, this ~~9th~~ day of December, 1975, by the following called vote:
