AN ORDINANCE AMENDING SECTION 2-251 OF TITLE 2, CHAPTER 2, ARTICLE 4 OF THE ORDINANCE CODE OF STANISLAUS COUNTY

THE BOARD OF SUPERVISORS OF THE COUNTY OF STANISLAUS DO ORDAIN AS FOLLOWS:

Section 1. Section 2-251 of Title 2, Chapter 2, Article 4 of the Ordinance Code of Stanislaus County is hereby amended to read as follows:

"Section 2-251. The Board of Supervisors of Stanislaus County, California, does hereby make the provisions of Section 31681.51 of the Government Code of California and Section 31739.31 of the Government Code of California as amended by Chapter 671 of the Statutes of 1967 applicable in Stanislaus County as a part of the County Employees Retirement Law of 1937, being Title 3, Division 4, Part 3 of the Government Code of California which is now in full force and effect in Stanislaus County."

Section 2. This ordinance shall take effect and be in full force thirty (30) days from and after the date of its passage, it shall be published once, with the names of the members voting for and against the same, in The Modesto Bee, a newspaper published in said County of Stanislaus, State of California.


