RESOLUTION

WHEREAS, it is in the best interests of the County of Stanislaus and the employees of the County of Stanislaus to provide that Government Code Sections 31621.5 and 31639.5, shall become applicable in Stanislaus County; and

WHEREAS, the adoption of such sections will implement the agreement between Stanislaus County and the Stanislaus County Employees Association as specified in the 1975-1976 Memorandum of Understanding; and

WHEREAS, to further implement such agreement, this Board elects to pay one-half the costs of the contributions which are assessed for cost of living increase pursuant to Government Code Section 31870.2; *- Typo see 31870.1*

NOW, THEREFORE, BE IT RESOLVED that Sections 31621.5 and 31639.5 be, and the same hereby are, adopted and such sections shall become applicable in Stanislaus County effective December 1, 1975.

BE IT FURTHER RESOLVED that pursuant to Government Code Section 31873, this Board elects to pay one-half the costs of the contributions which would otherwise be assessed to the individual members, effective December 1, 1975.

Upon motion of Supervisor Paul, seconded by Supervisor Simon, the foregoing resolution was passed and adopted at a regular meeting of the Board of Supervisors of the County of Stanislaus, State of California, this 9th day of December, 1975, by the following called vote:

ORDINANCE NO. N.S.- 74

AN ORDINANCE AMENDING ARTICLE 4, CHAPTER 2, TITLE 2 OF
THE ORDINANCE CODE OF STANISLAUS COUNTY
RELATING TO THE RETIREMENT SYSTEM BY THE ADDITION THERETO
OF SECTION 2-252 RELATING TO COST OF LIVING
ADJUSTMENTS FOR RETIRED COUNTY EMPLOYEES

THE BOARD OF SUPERVISORS OF THE COUNTY OF STANISLAUS, STATE OF CALIFORNIA, DO ORDAIN AS FOLLOWS:

Section 1. Pursuant to Section 31874 of the Government Code of the State of California, Article 4, Chapter 2, Title 2 of the Ordinance Code of Stanislaus County is amended by the addition thereto of Section 2-252, relating to cost of living adjustments for retired County employees, to read as follows:

"Section 2-252. The provisions of Sections 31870.1, 31871, 31872 and 31873 (Chapter 3 of Part 3 of Division 4 of Title 3) of the Government Code of the State of California are hereby made applicable to the County of Stanislaus, to be operative at 12:01 a.m., January 1, 1970, subject to the following:

- (a) A special reserve account shall be established entitled Cost of Living Adjustment Reserve.
- (b) The amount held in the Contingency Reserve as of the operative date of this section, which is in excess of 1% of the retirement system assets, shall be transferred to the Cost of Living Adjustment Reserve.
- (c) Each employee shall be required to contribute to the Cost of Living Adjustment Reserve a percentage of his compensation based upon sex and age and time of entering into the retirement system, as determined by actuarial survey of May 29, 1968.
- (d) The County shall contribute a monthly amount equal to that contributed by the employee, adjusted each month by the amount of the cost of living contributions refunded to the members during the month.

(e) All contributions shall be made on a refundable basis.

(f) Regular interest shall be credited to the Cost of Living Adjustment Reserve in the same manner as for other retirement reserves.

(g) The rates as provided by the actuarial consultants prior to the adoption of this section shall be reviewed at each periodic re-evaluation of the system as required by law."

Section 2. This ordinance shall take effect and be in full force thirty (30) days from and after the date of its passage, and before the expiration of fifteen (15) days after its passage, it shall be published once, with the names of the members voting for and against the same, in The Modesto Bee, a newspaper published in said County of Stanislaus, State of California.

Upon motion of Supervisor Brink, seconded by Supervisor Fahey, the foregoing ordinance was passed and adopted at a regular meeting of the Board of Supervisors of the County of Stanislaus, State of California, this 24th day of June, 1969, by the following called vote:
