Virgil Thompson informed the board that he attended the JP Morgan – Fleming Asset Management conference in Santa Barbara and will have a report completed for the May meeting.

Paul Harte informed the board that the transition had been completed and that most of the activity occurred on April 1<sup>st</sup> and 2<sup>nd</sup>. Funds were moved from Dodge & Cox to Bank of New York (the new passive equity manager), Charlotte Capital (the new small cap value manager), MFS and TCW.

Paul Harte also informed the board that StanCERA's policy guidelines will be updated and that he will work directly with Robert to revise the policy and submit the revisions at the meeting in May.

Nick Blom requested County Counsel to research information and cause of a recent lawsuit between Kern County and their actuaries.

Kent Crawford notified the board that the Oregon School Boards Association had recently issued a 26-year pension obligation bond @ 5.45%.

Karen reminded board members that the meeting of May 27, 2003 would begin at 10:00 a.m.
