The court has been sent a judgment whereby judgment is to be entered in favor of StanCERA and against the plaintiffs. StanCERA is waiting for the judgment to be signed. The plaintiffs will have 60 days to decide whether to appeal after the judgment is entered.

Mr. Ford distributed his memorandum dated October 13, 2010, entitled, "Mass Media Policy Conflict." Mr. Ford informed the Board he has had conflict and concern regarding the Board's Mass Media Policy adopted on June 11, 2008.

Mr. Bettencourt inquired about the status of opinions requested from the Fair Political Practices Commission and the Attorney General's Office regarding his recusals during closed sessions on the Michael O'Neal et al v. StanCERA matter. Mr. Silva responded that continuous follow-up has been done with the state agencies, with no responses from them to date.

Mr. Bettencourt requested a closed session item be placed on the October 26, 2010, Board of Retirement meeting agenda regarding the potential to make public a former County Counsel legal opinion.

Mr. Gharat requested Mr. Ford's memorandum dated October 13, 2010, be placed as a closed session item on the October 26, 2010, Board of Retirement meeting agenda.

Mr. Gharat also requested that a request for filing an amicus curiae brief be placed as a closed session item on the October 26, 2010, Board of Retirement meeting agenda.
