#### 6. Semi-Annual Performance Report by Pyramis Global Advisors

### M. De Anda arrived at 2:05 p.m.

Brian Higgins, Senior Account Executive, and Chris Steward, Institutional Portfolio Manager, gave the semi-annual presentation of StanCERA's international growth equity investment performance for the period ending September 30, 2010. The presentation was held via teleconference.

StanCERA's cumulative return (gross of fees) for international growth for the quarter is 16.74% compared with the benchmark MSCI ACWI Ex-U.S. (Morgan Stanley Capital International All Country World Index Ex-U.S.) index rate of return of 16.58%. StanCERA's portfolio total net assets as of September 30, 2010 are \$135.9 million. Portfolio returns for one and three years (gross of fees) are 9.67% and -6.72% compared with index returns of 7.56% and -7.42% for the same time periods of time. Since inception of the portfolio (May 11, 2006) the return is 0.65%.

### 7. Semi-Annual Performance Report by LSV Asset Management

Keith Bruch, Partner and Director, Client Portfolio Services, and Bhaskaran Swaminathan, Partner, and Director of Research, gave the semi-annual presentation of StanCERA's international value equity investment performance for the period ending September 30, 2010. The presentation was held via teleconference.

As of September 30, 2010, StanCERA's international value equity portfolio totaled \$131.8 million. StanCERA's 2010 third quarter return was 15.6% (net of fees). The one, three, and five year returns (net of fees) were 7.8%, -8.3% and 3.7%, respectively, compared with the value index returns of 3.8%, -7.8% and 3.9% for the same time periods,

#### 11. Members' Forum (Information and Future Agenda Requests Only)

Mr. Silva updated Board members in the matter of Nasrawi et al vs. Buck Consultants. The matter was set for a hearing to dismiss it on October 18, 2010. At the request of the Plaintiffs' it was then converted to a motion to remand it back to Superior Court. Initially, the case was filed in Stanislaus Superior Court and Buck Consultants removed it to Federal Court. The Plaintiffs then filed a motion to remand it back to Superior Court. The Plaintiffs lost on that motion. Buck Consultants then filed a motion to dismiss. In the Plaintiffs' opposition to the motion to dismiss, they requested a rehearing on the motion to remand. Judge Wanger scheduled a hearing for November 1, 2010. Judge Wanger states in the minute order of October 18, 2010, that he will rule on the motion to dismiss on the same day as the hearing of November 1, 2010.

Ms. Cerny announced that Trustee Mike Fisher submitted his resignation from the Board of Retirement, effective November 1, 2010. Mr. Fisher's written resignation letter was distributed to Board members.
